### Clinical Field Guide

Clinical Field Guides are our front line staff responsible for ensuring a safe and therapeutic milieu in the backcountry for groups of approximately six emotionally-struggling participants between the ages of 13-17. This position works in collaboration with the Certified Field Guide and an additional Field Guide, and is jointly responsible for daily group living and backcountry travel, supervision and assurance of physical & emotional safety, facilitating curriculum, teaching primitive skills, and participating in weekly treatment meetings with the Program Therapist. This person's professional clinical knowledge increases the Guide team's collective knowledge of therapeutic interventions and clinical conceptualizations between visits with the Program Therapist while ensuring that youth's therapeutic assignments are completed. This position is ideal for license candidates with their Master's degree in Counseling or Social Work who are acquiring direct hours for licensure, and who have experience working with mandated or reluctant clients, and must additionally be competent in backpacking in all weather conditions. Field guide positions work a rotating schedule of nine-day shifts, with two weeks off between the expeditions. Our publicly funded agency is able to provide \$150/day, plus a stipend for our staff training and University credit for applicable internships. Duties include:

- Actively participate in week-long backcountry staff training
- Provide direct care and vigilant supervision of clients throughout each day, including maintaining emotional and physical safety in the backcountry, with daily time for self-care away from the group while safety is secured. Remain within earshot of group at all times, even when "on break" in case of emergency.
- Collaborate with Field Guide co-workers to build united front and avoid displaying hierarchies within the staff team to group participants.
- Provide 1:1 sessions with each participant daily to facilitate activities related to treatment plan
- Facilitate program curriculum, including primitive skills and academic courses for High School credit.
- Complete all required documentation on daily basis, including case notes for individual and group therapy sessions, and forms required for licensing and maintaining confidential client health records.
- Execute individualized treatment plans as designated during weekly treatment meetings with Program Therapist
- Provide first aid as required and within scope of certified First Aid and CPR training.
- Ensure all youth files required for licensing remain in the field and ensure HIPAA security of all case notes
- Daily communication with on-call staff at base at designated times (shared responsibility with all Field Staff).
- Strictly follow Policies & Procedures, including reporting any accidents or violations through Incident Report protocol.
- Physical restraints are very uncommon but possible and non-violent restraint protocols must be strictly adhered to and documented (as provided during training).
- Maintain professional relationships with program participants, including acting as an example in all areas of personal conduct & hygiene.
- Participate in 1:1 Clinical Supervision sessions (via phone or zoom) for the purpose of employee wellness and professional development between shifts.

### Requirements:

- Must be at least 21 years of age as required by DPHHS
- Master's Degree in Mental Health Counseling, Social Work, or equivalent, preferably completed by May of 2024.
- Must be able to clear State and Federal background per DPHHS check and satisfactorily complete provided non-violent restraint training prior to working with participants.
- Possess and maintain current First Aid and Adult CPR certification.
- Must pass medical physical exam (post-employment offer), & be able to lift/carry up to 70lbs.

*Due to the unique backcountry work environment and critical needs of program participants, staff must disclose medical conditions during the interview process. Our agency does not discriminate based on diagnoses that do not impact the ability to perform duties, yet requires awareness of conditions to assess whether the health needs of the staff member can be appropriately accommodated as necessary to ensure the ongoing safety of program participants.*

- Actively participate in pre-season Staff Training
- Expressed mastery of primitive living and emotional de-escalation skills of self and others.
- Strong professional references from academic advisors and employers in mental health services.
